Lenape Tracking Club of Central New Jersey does not agree to arbitrate claims as set forth on the Official AKC entry form.

Exhibitors should follow their veterinarians' recommendation to assure their dogs are fee of internal and external parasites, any communicable diseases, and have appropriate vaccinations.

NOTICE TO EXHIBITORS

CLOSING DATE for the test is 12:00 p.m., Thursday, November 10, 2016, after which time entries will not be accepted, canceled, altered or substituted.

ENTRIES shall be accepted up until the official closing date, even though the advertised limit has been reached, and a drawing will be held within 48 hours of the closing to determine which entries will participate in the test.

DRAW FOR ENTRIES will be in the presence of the Tracking Test Committee at 7:30 p.m. on Thursday, November 10, 2016, at Panera Bread, Flemington Mall, 325 US-202, Flemington, NJ. The drawing shall be completely at random among all the entries received, except that preference shall be given to those dogs which have not previously earned a title. When the advertised limit has been drawn, all remaining entries shall be assigned a position on Alternate Lists corresponding to the order in which they were drawn. The Secretary shall then notify all entries of the results of the draw.

TEST WORKER OPTION AKC Worker Option will be used for this test. Two tracks will be reserved for members who meet Lenape's working member requirements (must work at four events over a two year period).

ENTRY FEES TD \$150 (includes AKC recording and event service fees). Entries not on official AKC entry forms & photocopies of entry forms without the Agreement and Rules on the reverse side of the official AKC entry form are not acceptable.

TELEPHONED, TELEGRAPHED, UNSIGNED, OR ENTRIES WITHOUT FEES CANNOT BE ACCEPTED. No entry shall be made and none accepted which specifies any conditions as to its acceptance. Returned checks do not constitute a valid entry fee and will have to be made good with cash or a money order prior to showing. The Test Secretary will add a collection fee to the amount of each returned check.

If because of riots, civil disturbances, or other acts beyond control of the management it is impossible to open or complete the test, NO REFUND OF ENTRIES WILL BE MADE.

ERRORS ON ENTRY BLANKS: Owners are responsible for errors in making out entry forms, whoever may make such errors, and no entry fee will be refunded, in the event of such errors or cancellation of entries after the published closing date.

BITCHES in season may enter this test. Test secretary must be notified. AKC rules will be strictly enforced.

REFUNDS. Entry Fees for an Alternate that does not participate in the Tracking Test shall be refunded within 7 days. In the event an accepted Entry withdraws after the closing date to allow an Alternate to replace said Entry, THE ENTRY FEE WILL BE REFUNDED. In the event an Accepted Entry withdraws after the closing date and there is no Alternate to replace said Entry, THE ENTRY FEE WILL NOT BE REFUNDED.

CANINE PARTNERS Dogs enrolled in the AKC Canine Partners program may participate.

EXTREME WEATHER CONDITIONS The Club reserves the right to cancel the test in the case of extreme weather conditions. In this event, the club will contact all entrants using contact information provided on the entry form.

In consideration of the acceptance of this entry and of the holding of this event and of the opportunity to have the dog judged and to win prizes, ribbons, or trophies, I (we) agree to hold the AKC, the event-giving club, their members, directors, governors, officers, agents, superintendents or event secretary and the owner and/or lessor of the premises and any provider of services that are necessary to hold this event and any employees or volunteers of the aforementioned parties, and any AKC approved judge, judging at this event, harmless from any claim for loss or injury which may be alleged to have been caused directly or indirectly to any person or thing by the act of this dog while in or about the event premises or grounds or near any entrance thereto, and I (we) personally assume all responsibility and liability for any such claim; and I (we) further agree to hold the aforementioned parties harmless from any claim for loss, injury or damage to this dog.

INSTRUCTIONS

- 1. (Variety) if you are entering a dog of breed in which there are varieties for show purposes, please designate the particular variety you are entering, i.e., Cocker Spaniel (solid color black, ASCOB, parti-color), Beagles (not exceeding 13 in., over 13 in. but not exceeding 15 in.), Dachshunds (longhaired, smooth, wirehaired), Collies (rough, smooth), Bull Terriers (colored, white), Manchester Terriers (standard, toy), Chihuahuas (smooth coat, long coat), English Toy Spaniels (King Charles and Ruby, Blenheim and Prince Charles), Poodles (tov. miniature, standard),
- 2. The following categories of dogs may be entered and shown in Best of Breed competition: Dogs that are Champions of Record and dogs which, according to their owners' records, have completed the requirements for a championship, but whose championships are unconfirmed. The showing of unconfirmed Champions in Best of Breed competition is limited to a period of 90 days from the date of the show where the dog completed the requirements for a championship.
- 3. (Event Class) Consult the classification in this premium list. If the event class in which you are entering your dog is divided, then, in addition to designating the class, specify the particular division of the class in which you are entering your dog, i.e. age division, color division, weight division.
- 4. A dog must be entered in the name of the person who actually owned it at the time entries for an event closed. If a registered dog has been acquired by a new owner it must be entered in the name of its new owner in any event for which entries closed after the date of acquirement, regardless of whether the new owner has received the registration certificate indicating that the dog is recorded in his name. State on entry form whether transfer application has been mailed to the AKC. (For complete rules, refer to Chapter 11, Section 3.)
- 5. Dogs entering mixed breed classes (eligible only in standalone Agility, Obedience, and Rally trials) should mark Breed as "MIXED
