PRACTICE SESSIONS



ALL DOGS MUST BE KEPT ON LEASH OR IN HARNESS AT ALL TIMES AT THESE PRACTICES We realize that most of the dogs are obedience trained, and sure its fun to let them run and play after a practice or a teack, but please remember we are quests that property's where we are holding our practices and matches. The odds against a problem between dogs in our cwn dogs is high, but remember these land owners often have dogs, sometimes their's or others are running loose, this could cause a problem. Since we are given the privilege to use these fields at any practice session or match, it is necessar to inforce this policy. Your dogs can be given free running times elsewhere. If you cannot abide by this then don't come to these outings. Anyone who does not comply will be asked to leave. It is difficult enough to get fields for practicing, we cannot abuse our privilege even if there is a 1 in 10,000 chance of something happening.

Practice Session: April 17th. At the dinner we decided with the match the last weekend of the month that we would only hold one practice this month. (Plus Easter weekend). Starting time 9AM. If no one has arrieved by 10am the instructor for the day will leave. Members only may practice, non-members are welcome to watch.

Location; on rt. 57 near Hackettstown, N.J. courtesy of Cerbo's Parsippany Greenhouses. There is no water available. on the grounds. There are several eating places nearby.

Directions: From North & East take Rt. 80 to Rt. 46 in Budd Lake. Follow Rt. 46 to Hackettstown (down long hill), at bottom of the hill at first crossroads turn left, follow map below.



Frem South and West; From South take Rt. 31 north to Washington. At light turn right onto Rt. 57. From West take Rt. 57 from Phillipsburg, thru Washington, across Rt. 31. Stay on 57 thruough Beattystown...start watching for the Mansfield Inn on the right. Driveway for the farm is on the left just before the Inn.

Remember to expect a possible change in your dog's tracking right after you start them on a heartworm preventative. It will only last a short time, from days to perhaps two weeks. Don't start thinking your dog as forgotten his training.

3rd Certification Match

April 24, 1977

Judge; Mr. Art Hartzell, Laureldale, Pa.

All tracks will be regulation AKC tracks. All dogs passing these tracks will be certified ready to enter AKC tracking tests by the judge. Dogs with a "T" may enter for exhibition if the tracks are not taken by dogs who have not been certified. There will be 10 tracks. Entries will be taken in the order by which they arrive in the mail. If the number of entries warrants a list of alternates will be maintained, in the event a dog is withdrawn a replacement from the list of alternates will be notifed. This list will be kept in the order by which they arrive in the mail. You will be notified by mail of the status of your dog's entry. Please include your telephone number on your entry in case we need to contact you if your dog has moved from the alternate list to a track.

Order of the tracks will be drawn at 7:30 am on April 24, 1977.

Please bring your own lunch, there will be beverages and desserts for sale at lunch time.

Reminder; Bring boots for wet morning tracks and binoculars, rain gear. These tracks are open to all, members and non-members.

Directions: From the North, West, and East. Proceed to the Flemington Traffic Circle, junction of Rts. 202 & 31. Follow signs for Rt. 12, Frenchtown, around the second circle. At third circle go past Rt. 12, take next Road, Rt. 523 to Stockton. Proceed 7.9 miles, passing through Sergeants-ville at a blinking light. At 7.7 miles a sign on left will read Sandy Ridge Baptist Church. Staying on Rt. 523 take next left turn onto a dirt road. Go in road to second gate on the left, turn into cabin which will be our headquarters. There will be signs posted.

From South or Southwest: Go to Rt. 29 in Stockton, N.J. heading for Baptistown. Right past the center of Stockton, Rt. 523 bears right, up a hill, proceed in this direction; for 1 mile. Turn right onto the dirt road. There will be a chain link fence on the left corner as you turn. Follow directions above.

Anyone interested in being a tracklayer should contact us. It is desirable that you come on the 23rd for the plotting of the tracks by the judge.
