



## World's Top Police Dog

### ... Amazing Golden Retriever Has Sniffed Out \$63 Million in Narcotics

A golden retriever named Intrepid never barks up the wrong tree - because he's "the world's top police dog," sniffing out \$63 million in narcotics and locating numerous missing people.

"I've taken him on 326 missions, and he has been 100 percent right on all of copter had failed to locate in them," boasted Intrepid's Authorities gave Tree a rein owner and handler, Tom Kazo of Miami. And the

Guinness Book of World Records says: "The world's top police dog is Trep of Kazo recalled. Miami, who has sniffed out \$63 million worth of narcotics."

In fact, a judge even issued a search warrant in Trep's name, which Kazo described as the first search warrant ever issued for a dog.

Miami Judge Edward Cowart said he was so impressed with Trep's record that he signed the warrant to search a house where the dog had indicated drugs. Sure enough, police found narcotics there.

Trep was turned over to the er nations. Dade County Sheriff's Dept. in Miami when he was 4 years old - and found more than a ton of hashish-on his very first case, on an assignment for the Customs Service in nearby Fort Lauderdale.

Trep was being led to a suspicious boat, when he stopped and began responding to a 48-foot racing sloop that had al-ready passed a customs in-spection, Kazo said.

The dog boarded the sloop and began pawing at a wall. When it was smashed open, 2,439 pounds of hashish were discovered.

All told, Kazo said, Trep has been trained to detect 16 types of drugs, 11 types of explosives -and missing people.

That talent was demon-strated in the Cayman Islands in the Caribbean, when Trep was flown in to find a missing man 47 searchers and a heli-


Authorities gave Trep a pair of the man's bathing trunks to piek up the scent. "Then they drove us to the last spot where the man was seen. I let Trep off the leash and we followed,

The dog picked up the man's tracks right away in an area of very rough mangrove trees, thick shrubs and jungle, said Rudolph Evans, a Cayman Islands police inspector.

"Within 45 minutes, the man was found alive,' Evans marveled.

Kazo and Trep left the Sheriff's Dept. in 1976 to work together as an independent team. They have handled assignments for 133 law enforce ment agencies in the United States, and for police in 14 oth-
