Mr. Stifel and Mr. Dearinger have shared your letter of June 18th, 1982, with me.

In order for us to consider the accreditation of any tracking club in order for it to conduct sanctioned tracking tests we would require that it:

- 1. Have an acceptable name- a name should pinpoint the club's geographic center of activity and at the same time be readily recognizable to someone in another part of the country-
- 2. Submit a membership list with the names and complete addresses of its members, in alphabetical order, with the designations B (breeder), T.E. (tracking exhibitor), O.E. (obedience exhibitor), D.O. (interested dog owner), and T.D. (for individuals who have placed tracking degrees on their dogs). We would also ask that you indicate the breed of dog owned by each of your members-
- 3. Submit an acceptable Constitution and By-Laws-
- 4. Function as a club over a period of time-
- 5. Have held "fun" matches-
- 6. Provide a record of the club's development including the events leading to formation, history, activities, meetings, community events, etc..

Upon submission of the aforementioned information we will notify you accordingly.



### Drug-sniffing wonder dog stalked by killers

A DRUG-sniffing wonder dog named Misty has been so successful that drug dealers have put out a contract on the animal's life.

Police are now taking extraordinary precautions, even dying Misty's hair to conceal her identity, to ensure that the German shepherd continues her crimebusting career.

Misty has "nosed" out more than a million dollars worth of marijuana, cocaine, heroin and morphine near Harrisburg, Pa.

"Confidential informants have told us that there is a standing offer among these dealers to reward anyone who kills Misty," says William Castle, the dog's owner-trainer and police chief of Carroll-Franklin Township. "These bums are running scare because Misty has put them o notice that not only will the com munity not tolerate these dru dealings, but we're going to fin their stashes of drugs."

Castle and Misty — who wer called the "dynamic duo" in a special citation of honor from Pensylvania Gov. Richard Thornburgh — have strongly deterredrug use among area students their frequent and unannounce visits to local schools and playgrounds, police say.

Drug dealers tried to poist Misty once by spreading a dead tranquilizer in an area where st was to sniff for a demonstratio It would have killed her, but p lice were tipped off in time.

### Even those without pets pay for puppy mills

Dog-breeding farms known as puppy mills are spreading into eastern Pennsylvania and South Jersey. They not only flood the market with substandard "purebred" dogs that cost buyers millions of dollars in veterinary fees, but they also generate social costs.

Dogs with physical or behavioral faults may be turned loose by their owners. And because of this, taxpayers must spend additional millions annually for the killing of surplus

pets in shelters and for the support of

dog-law enforcement.

Though hobby breeders who produce quality purebred dogs are turning out fewer animals, American Kennel Club registrations continue to rise. More and more pets are bred in puppy mills. These dogs are whelped by bitches sometimes chained to barn walls. Some begin their lives in conditions of almost

indescribable 111th, with no "socialization" to make them fit for family relationships. The first few weeks of its life that a breeder spends holding, talking to and loving a dog have been shown to directly affect whether the dog will be trainable and affectionate.

In certain parts of Pennsylvania, particularly in Lancaster County, dogs are bred on almost every farm. Some are sold on the farm; others are sold to pet stores or at the notorious dog auctions still permitted in Pennsylvania.

Puppy mills have been a multimillion-dollar business in the Midwest since the 1920s. There, hundreds of bitches in single establishments are bred every six months until they are too old or too sick to produce. They are given minimum care and just enough food to keep them turning out litters.

Conditions include several dogs crammed together in rusty barrels, old washing machines and chicken coops, with no room to exercise and nowhere else to relieve themselves. Members of Pennsylvania kennel

clubs report similar conditions on some farms.

Most puppy-mill operators care little about selecting for reproduction healthy animals with sound heredity. Two dogs are bred, the pups are bred back to the mothers and fathers, and sisters to brothers, and this continues generation after generation.

Buying a dog is like buying a diamond. The purchaser must rely on the integrity of the seller and must take time to find the right dog from the right source.

### A revised dog law is best defense against puppy mills

"The consequence of the meeting on puppy mills held by the Lancaster Kennel Club is a vacuum," said William Hartman, president of the Pennsylvania Federation of Dog Clubs. Though about 500 people from 90 clubs in five states attended the meeting in April to fight the movement of factory puppy breeding into Pennsylvania and South Jersey, ever dog lovers seem to have adopted a "let George do it" attitude.

The American Kennel Club (AKC), which registers some of the dogs from puppy mills, says the club members should educate the public

in the ways that consumers lose by buying puppy-mill dogs. The clubs think the AKC should play a big role, since it has the money and personnel required and its stated objective is to protect the integrity of purebred

It generally is agreed that better dog laws are needed in Pennsylvania to protect the state from puppy mills, which have been forced to localize their operations because of tightened federal regulations on animal shipments.

For 20 years, dog fanciers in Pennsylvania have fought to improve state dog laws, and their efforts have been led in the last 10 by the Pennsylvania Federation of Dog Clubs. The fight rarely got out of the House Agriculture Committee, which has jurisdiction over the issue.

Now there are signs that House Bill 2535, introduced in the committee recently, may have a chance. How good a chance? Well, it is an election year, and Dorothy Keith, head of the Pennsylvania federation's legislation committee, said that Rep. Joseph V. Grieco, Agriculture Committee chairman, noted that getting the bill to the floor for a vote would depend

on how much favorable mail he received on the subject.

Only the most-outrageous violator of animal welfare could object to the bill's mild provisions to amend the state's dog laws. Cost of licensing kennels would range from \$30 to \$300. There would be licensing and inspection, at a cost of \$150, for dog auctions.

Dogs under eight weeks of age could not be sold. An excellent provision is a \$10 fee for lifetime licensing of a dog with an identifying tattoo (\$8 for neutered dogs with such a tattoo), and fines of of \$300 to \$1,000 for tampering with the tattoo. Dognappers try to remove tattoos be-

cause they are proof the dog was stolen.

Dog license receipts would be shifted from the state general fund to a dog-law fund In 1980, the state got about \$1,350,000 from licenses. It is estimated that at most one-third of the dogs in Pennsylvania are licensed. The state kicked in an additional \$500,000 for all work of the Bureau of Dog Law Enforcement, including investigations of cruelty.
