

BRIEF GENERAL MEETING - approval of new members (see last newsletter); approval of Nominating Committee.



#### Recommended Reading:

Recently I ran across three interesting books at our local library. Pets and Their People by Bruce Fogle (Viking Press (14.95) This book was enjoyable to read, filled with many case studies and focused on the relationships of the vet, his clients and their pets. The emotional bonds between people and their pets was explored and pet therapy is discussed.

The second book was a novel Nop's Trials by Donald McCaig (Crown \$14.95) This novel takes the reader to sheep dog trials and through the travels of a border collie who gets kidnapped. In places the author tries to think like the dog and writes as though he is the dog. The descriptions of the dog working the woolies are worth the reading.

The third book Fup A Story by Jim Dodge (Simon & Schuster \$7.95) is a classic American tall tale. A short book or perhaps a long short story it has one section that involves Tracking. I will say no more as that would give it away, if you are looking for a good laugh read this one for sure.

Follow Rte. 513 to and through High Bridge. Just past  Voorhees High School turn left onto Rte. 628 (Woodglen Road). Ther  is a Chevron Gas Station on the corner. This turn will be 3.9  miles from the light on Rte. 31. Follow Rte. 628 to full stop at  Hill Road and turn left (Rte. 628 west). As you proceed, note  buildings on left. First will be the Lebanon Township Firehouse, then the Municipal Building and then the First Aid Squad Building.  Total mileage from Rte. 31 light: 5.7 miles.
