THE MAGIC OF TRACKING

or

Tracking in Austrailia? Who me???

(Received this article from Charlotte Schwartz in Aug., no room in the last newsletter, our apologies Charlotte, but here it is...)

My notebook cover reads "Degen's Tracking Log". Inside, on the first page, it says:

"July 1, 1984 Well, here I go again! This time it's Degen, age fourteen months, Greman Shepherd Dog. He loves to eat so he should enjoy tracking the Johnson way. I'll be OK as long as He doesn't have to move out more than 15' from me --- my hand is still very weak from the recent surgery and the scar is VERY tender. (Unlike Morgan, Degen's a slug around the house and he just may chose to track more slowly -- at least at a pace these old legs can keep up with -- and then I'll be fine.) We'll begin on a &' lead until he gets going. Wk 1 - cool, wet grassy field, wind 5mph, 50 degrees, early am.

Day 1 - 3x and Day 2 - 3x

He had no food at home last night. I put mest on the track. He was very hungry but was more interested in the smell of meat on my hand than what was on the ground. Oh well, tomorrow should be better."

Well, tomorrow was better and the next day was better yet. In fact, as with most dogs, each day's tracking improved over the previous day's performance. What was it Glen once told me? "the best teacher in the world is a hungry stomach."

Now, six weeks later, Degen is my tracking friend. He has built up muscle, has developed a fine nose, and learned to concentrate on his work. We no longer go out every morning because the groundwork is done -- he'll never forget how to use his nose -- and now we just rack for fun several times a week. We've tracked over frost, in the rain, against gale-type winds, in fog so thick we couldn't see the thirty-pace flag as we stood at the start. We've tracked in lush grass, trough prickly thistles that bite a dog's feet and a handler's ankles, through weeds and brush crotch-high, over fields peppered with sheep manure, and through cow menure that was so strong I wondered how he smelled anything but the menure.

We've done it all. But nosework isn't the only thing we got out of tracking. We got more than money can buy or a book can tell about, but let me try.

First, Sue Hill, who owns Degen, and whose home I'm visiting these two months, said to me the day we began, "Now that Degen's going to learn to track, he should sleep in your room with you. That way you two can build a bond together."

I agreed and, that night, Degen moved in complete with his brown blanket and nightime cookie (they call them buscuits in Australia). Well, the first morning, Degen thought that 6AM was late enough to sleep so he woke me with a wet tongue in the face. Needless to say, it didn't take me long to convince him that I prefer to arise about 8AM! Now, he waits for me to get up first.

The next week, Sue said, "I'm starting a new beginner odbedience class tonight and since Degen has never been through one, I think it would be just great if you'd train him for me."

Well, how do you say "no" to your hostess when she asks you a question like that? Anyway, lacking a rapid response that would get me out of it, I once more agreed.

Tonight we go to lesson number six and, actually, it hasn't been all that bad. Except that I do wonder every once in a while, what am I, an obedience instructor on vacation, doing in a class like this...in Australia yet?! Oh, it hasn't been all peaches-and-cream. Degen hated it for the first four weeks...remember I said he's a slug. But, when he's hungry and I'm very UP, he doesn't mind it too much. At least we're as good as any of the others in the class, better than most and everyone thinks he's just brilliant. (Nobody's said anything about me being brilliant, but then who watches the handler anyway?!)

Seriously, Degen and I have now built a bond between us and, though I must leave here in another few weeks, I know he'll remember me the next time I return. Actually, I wouldn't be a bit surprised if I hear that he really misses me when I first leave. You see, this bond thing is very mysterious, magical and powerful.

You can't see a bond between a dog and a person. It's not a sign that pops out on the dog's chest that reads "This person is mine." And the dog will never announce to the world, "I belong to this person." Nope, to most people it's invisible.

But to the dog and his person, it's very obvious and loud and strong and beautiful, And they both feel it. It's just there like a certain feeling you get when you hear your favorite song or see a photograph of someone you love. It conjurs up vibes that pass invisibly between you, this bond.

I'll give you an example. Sue and I teach obedience classes in a large fairground pavilion that's laid out in two levels. Sue teaches on the lower level and I teach on the upper level. There's no door or barricade between us --- just a ramp leading from one to the other.

When we go to classes, we take Brock, Sue's German Shepherd, and Degen with us. Both dogs stay on the lower level with Sue on a long bench on which we spread their blankets.

The other night, in the middle of my class, a bystander called out to me that a loose dog was coming up the ramp toward my students. I walked over to take a look and, there, with his ears layed back as if to say, "I'm sorry, boss, I just couldn't wait any longer for you!" was degen. He'd chewed through the lead that tethered him to the bench and found his way through all the people and the dogs to me. That's bond. He was happy to be near his dog friend and his owner, but, more than anything, he wanted to be with the person with whom he's built a bond.

That's the MAGIC of tracking! Charlotte Schwartz

I'VE GOT MINE

The sport of Tracking becomes a more complete entity with every mail delivery. Now we've got a CAUSE. No more envy of Obedience people tilting at the AKC windmill over jump heights. Now us shabby creatures in the muddy sneakers and sweat-creased denims, odd types with weed seeds on our shoelaces, warm weenies in the pockets of disreputable flannel shirts, and gloves in our armpits, are invited to join ranks. Lenape Tracking Club of New Jersey is doing the organizing. They seem to be a sincere bunch with a lot of years experience in the game.

The cause to which they are rallying us is AKC's recent ruling which requires all entries to a Test, from the time the premium list appears till closing, to be subject to a drawing. I'm sure our fearless leaders had in mind addressing the complaints of nonclub-members who often find it impossible to get into anybody's Test, particularly in the Midwest and East.

The main objection to this ruling, an objection we can all embrace, is the summary way it appeared on the scene, evidently without discussion with any of those who might feel concerned, namely But who's Trackers. surprised? AKC, and the December 1984, FRONT and FINISH, Page 5

Obedience Department particularly, know nothing about Tracking and what's more, couldn't care less. So far as I know, the only Rep they've ever had with real knowledge of the subject was Fred Effinger - when he resigned we were left with a well-meaning bunch who know the reg's to a fault and nothing else.

But Lenape's arguments are faulty. They cite, as primary drawback, difficulty of keeping a possible entry in condition till two weeks before a Test. Anyone sincerely in this game would in any event have his dog ready, because dedicated handlers don't slack off when no Test is in the offing - they are out there working their dogs every week because that's what they like to do. And I've never met a likely prospect for winning T or X who wasn't being worked at least twice a week, and stepping that up to the optimum three times weekly will bring that dog up to peak performance.

I'm afraid that those who embrace such arguments are demonstrating the very cupidity which AKC was attempting, in its hamhanded way, to remedy. They are really saying: "We do all the work and deserve to keep the entries to ourselves as we need them." Not out loud, however. But no AKCsanctioned organization is chartered to permit this sort of member preference. And if these same protesters are really thinking, "Let the outsiders hold their own

Tests," they'd better consider that one over again. Because our clubs count on their neighbors, organized or not. to help fill entries at one time or another, and anyway do they really want that many additional Tests on the books? Then nobody would fill, and Tracking would become even more of a break-even risk. And the result would probably be less Tests offered, rather than more.

Lenape would like to see the alternate TDX track used if still available, allowing a sixth dog to try for its X. We're all singing that song --I first advanced the idea in an '82 FRONT and FINISH column titled Waste Not. Want Not. But AKC has already scotched at least one attempt to let that sixth dog run (see the account of the Allentown TDX Test in last August's GAZETTE.)

Stand up and be counted, folks. But count me out of the new entry-drawing furor. Let's give the outlanders an even chance for a change.


Fall Tracking Match:

PROPOSED AMENDMENT CHANGE

Once again we forgot one small section that needed changing.

Article 4, Section 4(c) Delete the sentence "There must be a minimum of two candidates nominated for each position."

Explanation for the deletion: The club is not large enough to insist that there be two candidates for each position. However the deletion of the sentence does not mean there cannot be two or more candidates for each position, it only means that it will not be required.

This change will become effective thirty days after the newsletter is mailed, unless we receive any objections before then.

WDEF update

The Working Dog Education Fund is making progress in its efforts to get bill a-1509. It is enticipated that the bill which was unanimously passed by the Agriculture and environment Committee will be voted on in the Assembly before the end of December. Since this action came late in the year, final action by the Senate and signature of the Governor cannot happen until 1985.

Letters to Assemblyman Alan Karcher in support of his efforts in getting the bill introduce in the Assembly would be appreciate. Thank him for his efforts thus far, and encourage him to continue the fight. Writing to your own Assemblyman would also be appreciated, if you don't have the address of your Assemblyman, you can obtain it from your local library, your town or county clerk.

WDEF is making this effort that will enable all "dog" people to work their dogs in various activities, protected from harassment by "well-meaning" SPCA officals and the like. Your support in this effort is needed. DO IT TODAY!!!!!!
