

#### SPECIAL AWARDS

# Dogs being tested to sniff out toxic dangers

Tracking dogs sniff out drugs, bombs, contraband food, termites and gypsy moths.

They sniff their way to escaped convicts, missing children and buried

avalanche victims.

Staffers at the federal Environmental Protection Agency in Edison have set out to prove that tracking dogs can also be taught to follow their noses to sites contaminated by chemicals.

An initial study has indicated that the idea is sound. But it will take about two more years to produce scientifically defensible data, said Hugh Masters, research poject manager at the EPA's hazardous waste engineering research laboratory in the township.

When a consultant made the proposal to EPA two years ago, it sounded ike "a common-sense idea" to Masters and other EPA staffers in Edison.

To the consultant, Herbert S. Skovronek of Morris Plains, it was more like an idea whose time may finally be coming.

He had proposed the idea to the EPA more than five years earlier,

when he was a staffer himself.

This time, approval was obtained for a study to be conducted by a pack of dog lovers including Masters, who owns. and trains tracking dogs, and Skovronek. a professional dog trainer for over 15 years. The study cost about \$20,000.

Justa, an 8-year-old black and tan temale German shepherd, and Niner, a 4-vear-old black male German shepherd, were sensitized to toluene and

trichlorophenol.

Both dogs are veteran narcotics sniffers and also trained in search and

"We went to the international experts," for the training, Masters said.

"Gien R. Johnson of Windsor, Ontario author of "Tracking Dog: Theory and Methods," instructed dog trainer Don Arner of Denville, co-founder of the North American Canine Olfaction Society, on a methodology, Arner trained Justa and Niner.

Each dog was handled by its owner, both associates of Arner.

In November 1983, Masters said, the dogs proved their worth by detecting from 25 feet away a drop of toluene on a piece of cotton encased in a hidden wood dowel.

A scientific instrument able to detect less than one part per million of the substance registered nothing until the instrument's probing device was placed in contact with the dowel, Masters said.

The dogs also performed well on variations of the game.

. "We don't understand this canine nose," Masters said, marvelling at its acuity.

He speculated that properly trained dogs could be useful to the EPA in several ways.

The point, he said, is to use the

dogs to detect very low concentrationsof chemicals-concentrations below levels picked up by scientific instru-

'The intent is never to use dogs in the center of identified toxic waste dumping sites," he said.

Rather, they might be used in residential areas on the perimeter of such sites to determine if any of the chemicals had seeped that far.

There would be two benefits to

this, he said.

First, an EPA staffer walking a dog could work inconspicuously, where-

as the traditional technician in a protective "moon suit" digging up soil samples for testing is an alarming sight to local residents.

Second, those samples are expensive to test for contamination. A dog's nose might do away with the need for collecting and testing soil samples at

Another possible application of educated canine noses, Masters said, would be to detect any remaining traces of chemicals on clothes, equipment and vehicles used in toxic waste cleanup jobs after those items have

been washed.

In the second phase, expected to get under way in September, sophisticated lab measurements will be made of exactly what concentrations of what chemicals dogs detect and from what distances, he said.

By such measuring, observing and recording, Masters hopes to develop the scientific data that could lead to the day when chemical-sniffing hounds work for either the EPA or for private contractors employed for chemical cleanups.
