

Betty Bailey has sent along the following First Aid tips for your canine friends:

PORCUPINE QUILLS: keep the dog quiet, quills are painful. Take the dog to the vet if possible. However, if this is not possible realize that quills are barbed and contain an air pocket. First cut the quill to open air pocket, then soak the remaining quill in vinegar to soften. Remove the quill with tweezers.

BEE STINGS: use cold conpresses and contact your vet. Dogs could possibly go into shock which in it self is an emergency!

BLEEDING: of first importance is to apply direct pressure to stop the bleeding -use a compress (can be cut from a sanitary napkin). AFTER bleeding has stopped, tape snugly but not tight and call vet. Vets give dogs tetanus shot. Compress and pressure are also the first aid in human bleeding.

BURNS: use cold water or ice pack NOT butter or oils. Burns are a real emergency so call your vet as soon as possible.

CARBON MONOXIDE POISONING: give artifical respiration - hold dogs mouth closed and breath into nostrils. Call police car for emergency oxygen if on the road. Remember to keep rear window of stations wagons CLOSED to avoid carbon monoxide poisoning.

SMOKE INHILIATION: is also a form of poisoning. Give oxygen as stated above. Smoke inhiliation can have severe after affects.
