

CONSTITUTION CHANGE/NOMINATIONS FROM FLOOR

DATE, PLACE AND TIME WILL BE SENT AFTER JAN. 20TH

At the January Board meeting a date will be set for a meeting in February. At this meeting we will vote on yet another change in our constitution. This change is not being requested by the AKC, it is because the members have voted to raise the dues of the members and this is covered in the Constitution.

We will be voting to change the amounts listed in Article I. Section 2 Dues to \$20 for Regular Membership, \$10 for each additional membership in one household. Junior Membership will be \$10. or we will be voting to change the wording in Article I, Section 2 to allow the Board and the Membership to set dues with having to change the Constitution each time. We are looking into other constitutions to see if that section can be worded to cover such dues increases without having to smend the constitution.

Also at this meeting is where the membership has to opportunity to make additional nominations from the floor for the 1989 officers.

Bear with us members, we will get it right. Eventually.

PEOPLE TRACKS; FRAN WILMETH

This is the place where we get to know one of our club members, and this time it's our top name on the slate of nominees, Fran Wilmeth.

Fran got started in "dogs" early, but they were not her own. Throughout her childhood she was not allowed to have a dog because her mother was allergic to animal hair. Fran says, "several neighbors let me walk their dogs so I had close relationship with several cocker spaniels, a Doberman, a Wirehaired Fox Terrier and a "Spitz". One spaniel, the terrier and Spitz learn to heel, sit at curbs to wait for traffic to pass, stay and come. One cocker retrieved a stick or a ball over a bar jump made from a bamboo pole. I was fascinated by what I could teach these animals but my ideas came from a book. I did not know about obedience classes. Finally, after completing my Masters Degree in psychology and getting my first full time job as a school psychologists, I spent my first pay check on a Welsh Terrier."

That first dog was picked after reading all the breed descriptions in the AKC Pure Bred Dogs book. Fran had three Welsh Terriers in all and two for 15 and 14 years. She obtained an English Springer Spaniel from a friend Fran met in an obedience class, but that dog was later placed in a foster home. It was happiest as an "only dog." Through the years, Fran had has 17 Doberman Pinchers. She bought her first Dobe after participating in a Doberman Drill Team with a borrowed dog. Fran said she found the Dobes to be much easier to train than the terriers, and after living with one Dobe for a while, she had to have more. Then, after 12 years of owning Dobermans, Fran decided she wanted another small dog, and again read through the standards. At one of our certification matches, she laid a track for Pam Riker's Misty, a Norwich Terrier, who passed the test in the rain. Misty was pregnant at the time and Fran was able to acquire one of her pups who is now Ch. Neversink Mollie Brown, CDX. Della's breeder had trained several collies in Fran's obedience classes and Fran suggested that she try one of her Schips. The breeder said to Fran, "You try it," and gave her Della who turned out to be a delightful dog to train and to live with.

In answer to a request to list all the titles her dogs have earned with their registered name, Fran said that the names alone would take up a whole page and summarized this information. But even the summary is impressive. Fran has owned 25 dogs in 38 years and they have earned 26 obedience titles and three breed championships. Her Welsh Terriers had 3 C.D.'s and 1 C.D.X. She put a C.D. on the English Springer. Her seventeen Dobes collected 12 C.D.'s, 2 C.D.X.'s. 1 T.D., 2 Champions and 1 Best in Show!. The three

Norwich Terriers went out and worked for 3 C.D.'s and a group C.D.X. and one breed Championship. And Della, the Schipperke has a C.D. and a C.D.X.

Fran became interested in tracking when she was training her Dobes at North Hunterdon High School. She met Peg Forte and Joanne MacKinnon, who had gotten involved in tracking and invited her to a meeting to organize a tracking group. Fran said, "I had seen a Dobe track and find my wallet in a field and decided to give it a try. I started with Vidar who developed so many bad habits because I didn't know enough, I dropped him and started Halla after going to Glen Johnson's seminar. Halla was close to certification but bad hips ended her career. Mollie Brown was gung ho but her allergies got so bad she couldn't go in the fields. We stuck with Carlotta for three years, finally getting a T. Now it's Morgan (Dobe) and Jackson (Norwich) that are in training."


Fran says she is not a breeder, she just "collects" dogs. She's active in obedience training and showing her own dogs, teaching obedience classes, attending obedience seminars, stewarding in obedience at AKC shows, writing the obedience column for the Norwich and Norfolk Terrier News, and occasionally judging at matches. In addition to LTC, Fran belongs to Suburban Dog Train Club where she teaches the open and utility classes and Hilltown Dog Training Club. She is a past president. She is also obedience chairman of the Norwich and Norfolk Terrier Club and is a member of the Doberman Pinscher Club of America, the National Association of Dog Obedience Instructors, the Obedience Stewards Club, and the Bucks-Mont O.H.A. where she is a former obedience instructor. Fran has also shown her Dobes and terriers in breed when she has had dogs worthy of such showing. In addition to all of this Fran enjoys dog photography and recently, dog agility. The "non-doggie" side of Fran Wilmeth is as interesting and as varied as the "doggie" side. She is single and has lived in her old former one room schoolhouse for 33 years. Born and raised in Springfield, Illinois, Fran received a BA from the University of Illinois, an MA from the University of Pennsylvania, and EdS from Rutgers University. She worked as a school psychologist at Woods Schools for 3 years and the Bucks County Schools for nine years. While in Bucks County her work covered the entire county. "I was a sort of circuit rider, Fran says, "testing kids in one room schools." She also worked in the Neshaminy School District in Langhorne, Pa., for 20 years. In 1982, Fran took early retirement but continued to work 2 days a week until June 1988. "Now, fully retired, I enjoy walking the Delaware Canal, bird watching, nature in general, photography and care of the house and the yard." derigne sat no .0.0 s tug sat

Hank would have gummed her "real good" if he could have reached her."

Letter TO AKC Regarding Tracking Clubs In Flarida

As Chairman of the Inter-club Communications Committee of the As Chairman of the Inter-club Communications Committee of the
Lenape Tracking Club of Central New Jersey, I am in frequent contact with members of various tracking clubs scattered across the
country. Some of these clubs are sanctioned by AKC to hold tracking tests and some, including Lenape, are in the process of seeking AKC sanction. The clubs often communicate with one another regarding their successes and failures in this process.

Richard Knapp of the Tracking Club of Central Florida has contacted us to express his concern over the New Club Operations Department's refusal to accredit his Club because only 30 of 100 members represent a "local" group. The remaining 70 members are scattered about the state but actively take part in Club activities.

At a meeting held November 18, 1988, the Board of Directors of Lenape Tracking Club voted to support Mr. Knapp and the Tracking Club of Central Florida in their request that new tracking clubs be permitted to cover regional, sectional or statewide areas rather than be limited to a local geographical zone. We feel this wider distribution of members is necessary in some parts of the country if tracking is to remain a viable AKC activity. In <u>Guidelines of Obedience Judges</u>, the AKC points out in Chapter 6, "Obedience clubs holding tracking tests should do so with full recognition that there is no way, financially for clubs to break even after paying the costs for promotional material, judging expenses, and providing for the comfort of the exhibitors." Here, in our general area, Dauphin Dog Training Club is not holding their TO and TDX tests this November, reportedly because of the expense of bringing in two TDX judges from the midwest as noneweere available nearby. Four area AKC Clubs have dropped their tracking tests within the past three years. These are Allentown Dog Training Club, (PA), Town and Country Dog Training Club (NJ), Princeton Dog Training Club (NJ) and Burlington County Kennel Club (NJ). There are no longer any regularly held tracking tests in the state of New Jersey.

If obedience clubs and all breed clubs continue to drop their tracking tests, new tracking clubs will be needed to continue the sport. Therefore, if tracking tests are to be made available in all sections of the country, it would seem that AKC may need to reconsider its policy on restricting the geographical boundries of tracking clubs since small clubs of 12 to 20 members would be hard pressed to finance such events. Once regional or statewide clubs are well established, it would seem logical that branch clubs or more localized groups could be formed in different sections of the state. Perhaps a time limit for the existence of the statewide or regional club could be set which would encourage the formation of more local groups as tracking became more popular. Interest in tracking appears to be growing but will diminish quickly if tests are not available within a reasonable distance for the participant.

> Lenape Tracking Club of Central New Jersey asks that AKC consider broadening the geographical area covered by tracking clubs so that small scattered groups of enthusiastic trackers can unite in their support of the sport and promotion of more tracking tests.

This concerns the presentation submitted on behalf of the Lenape Tracking Club of Central New Jersey requesting accreditation in order to conduct sanctioned tracking/T.D.X. matches.

Our committee has reviewed the information recently submitted on behalf of your club and in its opinion, at this time, feels that we can approve your club to apply for and conduct informal tracking/T.D.X. matches.

It is our feeling that all newly accredited tracking clubs should conduct at least one successful informal tracking/T.D.X. match before approval is issued for the holding of "Qualifying" tracking/T.D.X. matches.

It is our recommendation that the club continue its growth and activities in the greater Whitehouse, New Jersey area and upon completion of at least one informal event write this office indicating the club's intentions of being approved for the holding of "Qualifying" matches.

Enclosed are copies of the Obedience Regulations, Match Regulations and the Guidelines for Obedience Judges, which dedicates a chapter to tracking. Under separate cover you will receive AKC's Show and Obedience Trial Manual.

Somewhere in this world is my catalog with the notes I made on it so I would remember what happened on the week-end of November 5th and 6th. And then came Joanne MacKinnon's turn. We all held our breath while her Golden Retriever flawlessly covered the distance between the starting flags and the article. And there was jubilation in the wet grass when her dog brought the article to her.

She was to be the only one. The Etchells' Cocker Spaniel almost made it. She chose the wrong direction at the last turn. And the dear Bassett didn't even get to the second flag.

Janet Quodomine had provided a delicious lunch. Other members had brought desserts. We ate well.
