



The VST (Variable Surface Tracking) test they were entered in was run by The Tracking Club of Massachusetts on the grounds of the Hanscom Air Force Base, Bedford, MA. Priscilla's notes about the site follow:

A quorum was not present, so no action was taken on items not previously approved. Board members are urged to remember to call if they cannot attend. We can reschedule if we will not have a quorum.

The discussion was called to order at 7:50 pm.

Correspondence: We received notice from the AKC that disaster plans must be drawn up for all events after 1/1/99. Several people inquired about me4mbership and were sent letters describing the club's activities along with a membership application form and copy of the most recent newsletter.

Treasurer's Report: Balance for the period 3/29/98-6/19/98 was \$6,840.46. Income for the period was 1,804.29 (of which 1216.30 came from TED) and expenses were 1,687.60 (of which 626.96 were for TED). John's analysis of income and expenses for one year shows that 46% of our income is from TED while 16% of our expenses are from TED. Thirty percent of our income is from annual dues.

Miktus Donation: Florence Miktus again made a donation of \$200 to the club. We could use this as an awards fund (needs approval by quorum).

TED Follow-Ups: It rained again for the second follow-up. Ten people were scheduled to come, but 5 showed up. The July session is Saturday the 11th. Topic: scoping out a field. Peg will call Hope to be leader.

Land Report: We can continue to use the Christie Hoffman Farm (Fairmount Farm Park) for our training sessions. They plan Bark in the Park for October 11 and want another tracking demo.

Certification Workshop: The date on the calendar was incorrect. It should have read Sept 19/20. This would give anyone who was certified the opportunity to send in an entry to Berks by 9/23. Peg has left messages for Romaine Halupa, Joyce Geier, and Carol Parkinson-Simpson to see if any of these people would be available to judge for us. Mollie Heide has been working on getting land near her. Peg will call Beverly Olsen to see if she could arrange for us to use the Monmouth Battlefield park. John will be chief tracklayer for the workshop. Mimi will be secretary. Flyers should go out at the beginning of August.

November Test: We've been approved by the AKC for 8 tracks. There is still enough land in the Lebanon Twp area for this. John will be chief tracklayer. Barbara will be secretary.

VST Seminar: It's still on for Nov 14. No snow please! Peg will get flyers ready for mailing in August.

Newsletter: John will send Janet money for more stamps. Peg will update the calendar and the flyer for the July training session.

Vests, aprons, and stuff: Peg's vendor found some aprons and pouches that might be suitable for carrying tracking supplies. The pouches would be about \$6.00 with logo. Golf shirts are also available at about \$20.00. John found a vest in Cabela's Fall catalog (see page 69: light weight orange vest for \$25.00)

Topic for future meeting: Ralph is working Friday evenings and will not be able to attend meetings, so we may wish to replace him on the Board. We may also want to review what is the best meeting time for members.

Directions:

From Flemington / Whitehouse: (Route 22 or Route 78): Take 523 North to Oldwick and Route 517 (523 turns right across from Hildebrandt Nurseries just before you enter Oldwick - stay straight and you will be on Route 517). Go through Oldwick and continue on Route 517 to Fairmount. At the traffic light by the Fairmount Methodist Church (little white church with white steeple and red doors) diagonally across from cemetery, turn left onto Route 512. The Christie Hoffman Farm driveway is the third driveway on the left.

From Chester / Long Valley: Take Route 24 and 513 to Route 517 South (left turn at light in Long Valley). Stay on Route 517 until you reach the intersection with Route 512 (cemetery will be 611 your right and the Methodist Church will be diagonally across the intersection). Turn right onto Route 512 and enter the Christie Hoffman Farm Park at the third driveway on the left.
