President's Tracks (or chicken scratchings)

Training Sessions are continuing, and we are still using the park in Tewksbury Township. For the time being we will have to work around soccer games - but they will provide distractions for the dogs - good experience. The board has decided that notice of the training sessions will be sent out via postcards - by now you should have received the one for the Oct. 10th date.

Lenape's Tracking Test will be held on Nov. 1st this year. The plotting of the tracks will take place the day before. Judges Sallie Richards and Sue Dolbin have been here to judge before and we are sure to have a great test.

John Etchells is serving as Chief Tracklayer for this event - he will be calling - looking for tracklayers. Remember that if you help lay tracks you are entitled to attend dinner with the judges on Saturday night. At this point the menu is a surprise, but I'm sure it will be up to Lenape's standards of fine cuisine and good conversation.

Even if you aren't ready to lay tracks, you are invited to come out and watch the plotting of the tracks (unless, of course, you are entered on Sunday). This gives you another opportunity to learn more about our sport of tracking.

Pat Blake, Priscilla Gabosh, Mollie Heide, and Barbara Greenfield are in charge of the food for the day. They will be calling members to help.

The **VST Seminar** is scheduled for Nov.

14th - the flyer for that event is enclosed. It should be an interesting day, with the opportunity to learn more about scent work from Tracking Judge Mike Clemens.

Barbara Greenfield and I ventured out to Macungie Park in PA, last Saturday morning to do a tracking demonstration for the German Shepherd Club of Lehigh Valley. Barbara laid a very nice track for Deacon, my Flat-coated Retriever, with the first leg about six feet from the bank of a running stream of water. He was very interested in the water and wanted to investigate, but once he got past the first corner he did an very nice job.

Several of the people watching have asked for information on our TED and seemed to be very interested. And the club gave us a nice donation which will be placed in Lenape's Education Fund.

This summer, with the lack of rain has not been the greatest for tracking, but some of us have braved the heat to train. Hope Meaker and I have been out often, usually tracking until dark and beyond - we have some new stories to tell of this experience.

While starting dogs we are also working on TDX problems, starts, multiple drops, obstacles, and aging for the most part. The heat and dryness of the ground cover has not deterred the dogs in their efforts. And we are learning much about TDX tracking.

Pricilla White dropped me a note with her VST Seminar entry in which she says Muffy has been entered several TDX and VST tests. So far she has made the draw into a TDX test in Concord, MA this weekend. Good luck Muffy and Pricilla - may you be the first to earn a VST - what am I saying - then we will have to design an award for VST titles - never mind that - get out there and use that nose, Muffy.

Certification Match

We had two sunny days for this event, there was even a lot of dew on the morning of the match to help boost the confidence of the handlers.

John Etchells did his usual good job as Chief Tracklayer. Vicki Brown, Barbara Greenfield and Peg Forte assisted him in laying the tracks.

The five entries gave us quite a variety of dogs, three retrievers, a Labrador, a Flat-Coat, and a Chesapeake were joined by an Irish Water Spaniel and an Australian Shepherd.

The first dog to run was James Friedl's Chessie - she was off to a good start, but Jim was willing to follow her into the woods on what was probably a deer crosstrack.

The second dog to put her nose down, was Lucy with new member Karen Oliver. They made short work of the track, five minutes flat. Karen and Lucy started their tracking at this spring's TED and they showed how the training sessions and their own hard work can pay off.

The next two dogs did not fare too well, although Carolyn Moran did report spotting a fox at the edge of the woods as she started her track. Kelly and Hope Meaker had some very bad breaks on their track, but Kelly showed great promise.

The last track was the Aussie, Bullet, with another new member Pat Losco. The dog did a fine job and was certified.

Barbara Greenfield provided a very nice spaghetti dinner for the tracklayers, the judge and the board members on Saturday evening after the tracks were plotted. On Sunday, Mollie Heide helped Barbara with the hospitality duties. Rick Andrews, who has been appointed to take Ralph MacKinnon's seat on the board, was helping out on Sunday also.

In a note received by Peg from Judge Art Twiss thanking her for hosting him on Saturday night, Art comments: "Just a short note to thank both you and the entire Lenape Tracking Club for allowing me to judge at your Tracking Workshop. I hope my activities met your expectations. I only wish more teams had certified."

BOARD MEETING HIGHLIGHTS
AUGUST 21, 1998

Correspondence: We received notification from the AKC and the NJFDC about making comment on changes proposed by the Doris Day Animal League to the federal animal care regulations. Secretary Mimi Ruch prepared a response from Lenape TC. Barbara Greenfield made a motion to send the response as written, seconded by Linda Riley. All in favor.

We also received from the AKC notification about Dog Day Afternoon in NYC on Sept 12, notification of policies on Judges' Misconduct Guidelines, Videotaping/Televising Guidelines, Disabled Handlers, and a white paper on their DNA program to ensure the integrity of the registry. Effective September 1, 1998, AKC has appointed Julie Eagle and Tina Poole to be our representatives in the Event Plans Department.

August Training Session: Went well with 3 new people and 6-7 current members. There was a problem with a large number of unleashed dogs; this frequently happens in parks despite the signs about leashing dogs. It's something we need to be aware of. It has been brought to the attention of the park committee.

Land Report: Ralph MacKinnon and Lisa Pattison inspected property on Pleasant Run Rd - approx 40-45 acres. The vegetation right now is very sparse, the fields may be planted in soy beans. Lisa will be inspecting for any signs of vegetation after it rains and confirm the planting schedule.

Joanne, Ralph, and Mimi inspected land in the Spruce Run Wildlife Management area for possible Spring use. The fields available are fairly small and have lots of briars and roses. Peg and Hope looked at a new county park near the Musconetcong and found heavy cover with lots of briars. Peg will look into the possibility of a farm near Penwell.

Certification Workshop: As of 8/21, three entries were already in. The pot luck supper will be at the municipal building.

November Test: Barbara will do food. Hope will be overall chair. Mimi

will prepare premium list and get it to Barbara.

VST Seminar: The ESC building and church property are available.

Training Session Announcements: Peg will do postcards for these instead of using the newsletter because timing doesn't always work for the training session leader or the newsletter editor.

Nominating Committee: Vicky Brown will chair. The committee must meet before January 1 and the secretary must notify all members of the slate before January 15. Nominations can be made from the floor at a general meeting in February. Voting is done at the annual meeting in March.

Lehigh German Shepherd Club Demo: September 26. Barbara and Peg will do.

Bark in the Park: October 11 (Sunday, same day as Ramapo). The Christie Hoffman Farm park committee would like another demo this year. They hope to give us an untrampled field. Abner can do the demo (he may bark, but that's the name of the game for this event). Ralph may be available to do the explanations. September and October are busy months for most of our active members.

Fund Raisers: We might be able to offer a mouse pad with a sketch of a track. Linda has a possible contact who is interested in making these. It might be a good idea to offer something without a logo that would be attractive to non-members.

Tippacano and Topi, Too

Midsummer and it's hot as a turtle on tarmac. My tracking dog, Topaz, doesn't care for heat. As a matter of fact, she lays down on a track in the sun and looks at me - a rather firm method of letting me know she quit. I don't even do obedience work in the summer - she'll appear to heel in the next ring she's so far behind. (Of course, in the cold, she's so energetic she's a leap ahead. Guess that speaks more to our obedience work than anything else.)

Still, Topaz needs exercise. So we decided to take her on her first canoe trip down the Wading River in Burlington County. My son brought his family and dog, so we became a convoy of two canoes heading downstream over the dark water with two adults, one child and one 60-pound dog in each. This venture is not as foolhardy as it may appear. The Wading River is relatively narrow, flat and slow moving - but it does have rather a lot of very tight bends, which have a considerable current. The river is cedar water - clean but so dark you can't see the many stumps hiding beneath the surface to surprise you. There are sandy shoals and stony banks in some places with grassy, marshy banks in others.

Now, Topaz sat in the canoe willingly enough, and was quite careful not to rock the boat after the first minute or so. But she clearly was not comfortable. Within the first fifteen minutes, she eeled over the side. Somehow, she managed to gracefully slither out of the canoe without upsetting the balance. My son wisely beached his canoe to let his dog, Keebo - an ebony shepherd / husky design - who was clearly jealous of Topi's freedom - out. We assumed the dogs would tire after a while and be better passengers. Three hours later and they were still swimming. And so were we.

Actually, we had been doing rather well until a branch attacked my husband from the shore tilting him, and thus the canoe. The dogs paused in their otter imitation long enough to laugh at us; big mistake. I shanghaied Topi into working for us by retrieving an oar before it vanished downstream (a retriever can be a handy canoe companion!). We got underway again with the only casualty being Topaz' lead which had been around my waist. The dogs meanwhile had discovered the sludge along the banks. Keebo almost got stuck in the stuff. He came out solid black. But then again, he went in solid black. Mine went in a golden, and came out a flatcoat. And Keebo didn't like it - or her. He went on the attack at this strange apparition, which suddenly appeared out of the swamp. I guess the mud also masked scent. We had to wash her off before he would accept her as his swimming companion again!

The rest of the trip was rather uneventful, but the dogs remained in the water. Never far, and always checking our progress. Usually Topi led the lead canoe, swimming the deep stuff, bounding over the shoals and sometimes struggling up very steep banks. The truth is, we only went about four miles - it was my first canoe trip, too - but I think the dogs swam twice that. When we reached our destination, Topaz had to be coaxed out of the water. We all had such a grand time that we're planning another trip in the fall, when the leaves cast their crimson and gold reflections on the ink dark surface, and while the water is still warm. Not that we anticipate a spill (one of my more adept friends wondered how we were able to spill in the comparatively flat slow waters of the Pine Barrens). I recommend the activity to anyone with a *small* dog, or a love for the water, up close and personal!

Directions:

From Flemington/Whitehouse: (Route 22 or Route 78): Take 523 North to Oldwick and Route 517 (523 turns right across from Hildebrandt Nurseries just before you enter Oldwick -- stay straight and you will be on Route 517). Go through Oldwick and continue on Route 517 to Fairmount. At the traffic light by the Fairmount Methodist Church (little white church with white steeple and red doors) diagonally across from cemetery, turn left onto Route 512. Fairmount Farm Park's driveway is the third driveway on the left.

From Chester/Long Valley: Take Route 24 and 513 to Route 517 south (left turn at light in Long Valley). Stay on Route 517 until you reach the intersection with Route 512 (cemetery will be on your right and the Methodist Church will be diagonally across the intersection).
