Training Sessions: Five more people (Priscilla White, James Friedl, Pat Losco, Karen Oliver, and Laurie Shuren) were certified as tracklayers at the December session. January session cancelled because of bad weather. We'll use January's topic, acute turns, for the February 14 session to be held at the Municipal Building. Topic for the March session will be one-flag starts and multiple drops to prepare for TDX to be held at Christie Hoffman Farm Park. Vicky will lead.

NEW TRACKING DOG TITLE

(See Peg's Report on Our '98 Test in Nov.-Dec. Issue)

From Karen Oliver and Lucille's Best Blues, CGC, CD, TD:

Getting to the Lebanon Township Municipal Building and waiting for everyone else to arrive, I felt my nervousness start to increase. As usual, I was early. After a while, the tracklayers went out to lay the first few tracks. I kept telling myself to calm down. I could tell the others were feeling the same way. Next thing I knew it was time for the draw. I was the first one. "Draw an early track" I kept telling myself. I wanted this test to be over with as soon as possible. Number 3 track was the one I drew. "Pretty good" I told myself. I went with the others to watch the first dog. It wasn't going well. I didn't want to watch and walked back to the parking lot. On to the next dog. I only saw that one at the end of their track and they were going strong. Success for them! I was next.

As I walked up to the starting flag I tried to remember everything everyone had told me to do. I just watched Lucy and went with her. The first turn, then the next. Lucy nosed around the turn. In my mind I heard Bev Olsen, my training partner, telling me she was going to drive spikes through my shoes if I moved (I don't think I moved too much). On through the field we went. I started to doubt myself. This track has to end somewhere around here! This track is going on forever! "Trust your dog" I remembered people telling me. We kept going. Lucy tracked faster. Another turn! On we went. Finally, Lucy nosed the ground and there was the glove. I have never been happier, I'll tell you. I picked that glove up and waved it for all it was worth. Do you think Lucy knew she had accomplished something? You bet! She carried that glove back to the Judges with her head held high and tail straight up in the air. Good job, Lucy.

Our thanks to all who gave guidance and wonderful encouragement, from Tracking Experience Day, the follow-up sessions, the Certification Test, through the Tracking Test itself.

Animals and drawing have always been a part of Robert J. Blake's life. Born and raised in New Jersey he enjoys sketching on the sites depicted in his illustrations and books. He will share some of his experiences with us at our annual brunch.

Akiak : A Tale from the Iditarod

Robert J. Blake (Author & Illustrator) Published 1997

It is Iditarod day. Fifty-six dog teams will race through 1,151 miles of rugged Alaskan terrain from Anchorage to Nome. Akiak knows these miles well. As lead dog, she has raced the incredible trail before, but never won. She is ten years old: if she is going to win, it must be now.

Directions:

From Flemington / Whitehouse: (Route 22 or Route 78): Take 523 North to Oldwick and Route 517 (523 turns right across from Hildebrandt Nurseries just before you enter Oldwick - stay straight and you will be on Route 517). Go through Oldwick and continue on Route 517 to Fairmount. At the traffic light by the Fairmount Methodist Church (little white church with white steeple and red doors) diagonally across from cemetery, turn left onto Route 512. The Christie Hoffman Farm driveway is the **third driveway on the left.**

From Chester / Long Valley: Take Route 24 and 513 to Route 517 South (left turn at light in Long Valley). Stay on Route 517 until you reach the intersection with Route 512 (cemetery will be on your right and the Methodist Church will be diagonally across the intersection). Turn right onto Route 512 and enter the Christie Hoffman Farm Park at the **third driveway on the left.**
