Hope served as chief tracklayer for our 1997 test in two days of pouring rain and had to herd the cows off a tracking field and hold them off while tracks were run. She has been one of our presentators at TED the past few years, has laid track at many certification workshops and tests, and has always been an asset to our club.

Linda Riley, a board member for 12 years, who served as Treasurer and TED chair for several years was thanked for her participation over those years. Linda earned the Gaines medal (back when they were available) for outstanding service. And while Linda will no longer be on the LTC board she will continue to help with taking the newsletter for copying and returning it to the Editor, Janet Horn, for collating and mailing.

Barbara Greenfield informed the board at their March meeting that TED 99 has its 24 tracking team entries and a waiting list has been started. As chairperson of TED Barbara has been working very hard to make our annual seminar a big success. Since very few people responded via the form members were mailed about helping, Barbara had to make many phone calls to get enough people to make it possible to proceed with TED 99.

The program for the brunch was Robert J.

Blake, author and illustrator of children's books many of which are about dogs. He enthusiastically related stories about breaking into writing and illustrating books about dogs. "RipTide" was the first of these titles. He told us how he went to the AKC office in New York to have them assist him in locating a Golden Retriever near his home in northern NJ to use as a model for the illustrations. Reader's Digest has Gone to the Dogs

Recent issues of the Reader's Digest have included articles of interest to those of us in the dog world.

On the serious side in the February 99 issue there is a special report entitled the "Scandal of America's Puppy Mills."
