President's Message

The weather for the Certification workshop could not have been better. Details on that event are elsewhere in this newsletter.

The Tracking Advisory Committee Report is out and appears in this newsletter. Please take the time to read their proposals. We first heard about the proposals from our Certification workshop judge, Lily Mummert, who had her copy with her which she shared with us over dinner after the tracks were plotted on Saturday.

We did not receive the original mailing from the AKC that was sent to Tracking Clubs (I thought we were one), so Mimi Ruch made some phone calls. She ended up talking to Jim Pitts, the Vice President for Tracking, Obedience, etc. who assured Mimi that he would get us on the mailing list for receiving such information. He also told her that they would like comments on the proposals by the end of October.

The board will discuss the proposals at their meeting on Oct. 15th. Since there is not enough time to call a general meeting to discuss the proposals please read them over. You can send comments to Mimi Ruch by Oct. 25th or send them directly to the AKC.

The *Tracking Test* location has been changed this year. It will be held on fields adjacent to Wertsville Road near Ringoes, NJ.

Peter and Mollie Heide have been gracious in offering us there home to work out of for the two days.

John Etchells is serving as the Chief tracklayer for the event and he will be calling those who are already Certified Tracklayers to put their skills to use. If you can't be there for all day Saturday, but can spare a couple of hours to plot your track with the judges on Sat. and return to lay the track on Sunday please do so. It would be nice to have each tracklayer only have to do one track.

Our judges for the test are Maureen Foley from Ann Arbor, MI who we are flying in for the event. Since we must reimbursed a judge for their travel expenses, the board decided that an airline ticket would not cost any more than the per mile cost of getting a judge from as far away as we sometimes have to do. The second judge is Allison Platt, another new provisional judge from Baltimore, MD. Both these judges come highly recommended and we are looking forward to working with them.

The Pet First Aid Course, Saturday, Nov. 13th, already has eight people signed up for each session. We are taking a total of 20 in each session. So if you are planning to come, and just haven't gotten around to signing up, do it now. The flyer was in the last newsletter.

Tracklayer Certification will be done at the Sunday, Dec. 12th Training Session. John Etchells and other members will lead those who want to be certified through the process. Only 20 of our club members are certified thus far, so if you haven't had the opportunity please plan to come out this year.

On October 10th, some of the Lenape members were at the Christie Hoffman Farm Park in Tewksbury Township, at the Bark in the Park annual event. Karen Oliver, and her yellow Labrador, Lucy did a demonstration track. We are invited to this doggie event because we use the park for some of our training sessions.

Lenape's 1999 Certification Workshop

The Certification Workshop had 8 entries this year. New tracking provisional judge, Lily Mummert drove down from New York state to plot the tracks on Saturday and then stayed over to judge the entrants on Sunday. Both days were picture perfect weather, with moisture on the fields in the morning and little wind, basically perfect tracking conditions.

John Etchells served as the chief tracklayer once again and did his usual fine job. Barbara Greenfield was in charge of the food and served as Workshop Chairman. Please see her report elsewhere in this newsletter.

Noreen Dowling, and her grey Newfoundland were entered "as not ready for certification" and they had the first track of the day. While they got off to a good start, they were not certified.

The next dog to run was Lisa Pattison's Australian Shepherd, Murphy who nearly qualified on the same field two years ago. This time he was successful.

Jeff Pierce, who attended this year's TED was next with his black Labrador Retriever.

What a pretty picture they made as they too ran a great track and were certified.

The next dog to run was another Australian Shepherd, handled by Lisa Pattison. This dog was distracted by gunshots in the distance and a tractor that came into the other end of the field, but she shows promise.

New Lenape member and a 1999 TED participant, Bob Malloy and his Aussie tackled a track in the big field across from the school. While they did not certify, Bob was encouraged and he will continue tracking with his dog.

The next two tracks where in a new field on Route 513. First up was Rose Kruser's Doberman, Alisa. This dog did a terrific track and made certification look easy. The second track was run by another Australian Shepherd, Shelby, handled by Lisa Pattison. They were also certified.

The last track of the day was a modified TDX track run by Priscilla White's Muffy. The dog had not been tracked for some time, but with a little help from the judge and the tracklayer they were able to finish the track.

The judge thanked us for giving her the opportunity to have the experience of judging our match. Lenape was pleased to have her judge for us and we are glad to have another judge available to us within a reasonable traveling distance, only 2 hours away.

Tracking Advisory Committee Report

The Tracking Advisory Committee met in mid-July 1999 and a summary of their recommendations is listed below. There was much 'give and take' during the almost two days and nights of the Committee meetings. The Committee members had already spent a great deal of time at home reading through all of the suggestions from trackers all around the country, and some even held local meetings of tracking enthusiasts, before coming to Raleigh.

One of the interesting issues discussed was that of creating enthusiasm for the Tracking Sport through the implementation of a Tracking Instinct promotional event. This-CGC-type event (certificate) would be geared towards introducing Tracking to more people.

The Committee Members also recommended adding two new tracking tests to the current Tracking Test procedure, while at the same time, providing a dual-track process for exhibitors. These tests include Tracking Dog Advanced (TDA) placed between the TD and TDX tests, and a Variable Tracking Dog (VTD) placed between the TD and VST tests. Details about these recommended tests are listed below.

These recommendations are being reviewed by AKC staff and prepared for submission to the Board of Directors of the AKC, before the end of 1999.

- Eliminating the grand-fathering of VST judges, and implementing a Regular Judging approval process for VST judges
- · Maintaining the requirement for two judges at each tracking test
- VST site approval to continue to be performed by AKC
- Allowing clubs to hold unlimited tracking tests, provided they have the land and personnel (currently limited to 4 trials a year)
- · Deleting the requirement for judges approval for handlers to give water to their dogs during a test
- Eliminating the 20-foot marker requirement on the tracking lead
- Changing the regulations to require that the leash must be attached on top of the harness, while
 tracking, and that the lead shall not be run deliberately through the underside of the dog
- That the regulations state that tracking judges will permit and encourage spectators to follow along on the track
- · Establishing a required program of continuing education for tracking judges
- Allowing clubs to have tracking tests on the same day as any other event they may have scheduled (e.g., obedience, agility, etc.)
- · The committee unanimously recommended that a coupon system for entries not be put in place
- Eliminating the 6 months waiting period between TD and VST Tests
- That National Specialty tracking events have the "option" of opening their tracking tests to all breeds. This would allow National Specialty clubs to choose either, only their own breed as they do today, or they could allow other breeds, through the use of a lottery. There would be four draws as indicated below:

First draw Specialty breed without a title Specialty breed with a title Other breeds without a title Other breeds with a title

Allow judges to implement an 'optional' 3rd cross-track

- Leaving the Alternate track as is, not to be used as an additional track
- Allowing the date and place on ribbons to be placed on a tag on the back of the ribbons, rather than
 printed on the front.
- That dogs may wear an Orange Vest, designed with an open bottom, saddle type cloth to be worn
 only during gun or bow hunting season.
- Requiring that the Test Draw time must be on the front of the premium list
- · Keeping both Judges maps for each track
- Create a basic entry level (CGC-type) 'promotional event', not a title, called Tracking Instinct (TI) this would be done at workshops or by clubs, like a hide and seek and it should be a 'win' for the dog
 and handler.

Tracklayer Certification

This training session will be devoted to certifying *members* to be tracklayers. All the tracks laid in our tests are by members who have been certified as tracklayers. Let John Etchells, and members who are already certified, take you through the process.

Bring a clipboard, pencils and a glove. Bring Your Lunch

- Participants will be paired. "A" will plot a track, drawing a map and putting in flags at the turns. "B" will follow "A" and draw his/her own map. Then the roles will switch. Next each will re-walk their tracks, removing all flags except the two starting flags and place a marker at each turn, making sure it is not visible from even a few feet away. A glove will be left at the end.
- After all tracks have been plotted and re-walked, we will break for lunch. During the lunch break, copies of the Tracking Regulations will be distributed and an Open Book test will be given.
- Then each person will walk his track again and must return with the corner markers and glove, using his
 map as a guide.
- Each successful tracklayer will be considered a Certified Tracklayer and will be mailed a certificate attesting to that fact.

From the East: I-78 to Exit 17 (Route 31 North). * Take Rt. 31 north - as you approach the second light, stay to the right as jug handle takes you off onto Route 513 at the 513 - Grayrock Shopping Center - at the STOP sign turn right and note mileage at this point. Follow Rt. 513 to and through High Bridge. Shortly past Voorhees High School, turn left onto Rt. 628. There is an old, unopened Sunoco gas station on the corner. This turn will be 3.9 miles from the light on Rt. 31. Follow Rt. 628 to full stop at Hill Rd. Turn left. Watch for brick buildings on the left - first a firehouse, then the Municipal Building, then the First Aid Squad. (Total mileage from light on Rt. 31 is 5.7 miles). Park in the rear of the buildings.

From the West: I-78 to Exit 15. Right at end of ramp. Take Main Street into the town of Clinton. At the light in the center of town, turn left onto Halstead Street (Route 513). Observe the speed limit here! Halstead will end at Route 31 where you turn left and will be at the first light. Follow directions above from *
