# Ben and Sky

#### BEN HOYLE AND SKY

Ben Hoyle and Sky have some news to share. On February 18 & 19, Sky earned his first to legs in Open A Obedience. These two trials were held by the Burlington County Kennel Club at the Lower Camden County Dog Training Club site in Lindenwold, NJ. It's been a long time since we have competed at this level and our nerves were probably a factor in our scores (172 and 181), but as they say, the green ribbon is all that matters.

On April 3 Sky made his TDX debut at the Clumber Spaniel Club of America tracking test, which was one of the events held as part of the National Specialty. The test site was at the Caesar Creek State Park and the Spring Valley Wildlife Area in Waynesville, OH. Our fabulous judges were Ken Barna (OH) and Betsy Baird (MI) who did a great job of planning our 3 TD and 3 TDX tracks. This was also my first time as test secretary for a

tracking test and I can thank Lenape Tracking Club for providing me with such a good foundation take on this task.

Sky drew the first TDX track and our judges warned us that the tracks were going to be challenging. Unfortunately, despite my previous conversations with park officials, we were not told that last fall some of the best areas for tracks were burned as part of their land management program. Ken and Betsy did plot our tracks in an available area, but the cover was short, hard stubbly grass and in many places thick, suck the boots off your feet mud. There was a lot of rain in the area leading up to the event, which didn't help the muckiness of the ground. Sky had a great start leading up to the start flag and found the scent on the first leg. He had trouble with the sharp ground cover and frequently hopped and kicked his feet. I think for Sky the irritation to his feet was a distraction and he over-shot the first turn when he saw soft grass ahead. We continued with our track layer, Matt Winters, and Sky eventually adjusted to the difficult ground cover. He managed to find all his intermediate articles without difficulty, was not distracted by the cross tracks, and was a dynamo in the areas of cover change. These areas were acres of dense thorny brambles that were 3-4 feet high. He, in good Clumber form, plowed into the brambles and was hard to hold him back. Once inside the brambles it reminded me of the final scenes from the Harry Potter movie, The Goblet of Fire, when Harry and

others had to go into the hedge maze. Sky's track ended after two legs in the brambles of almost 250 yards at which point he found the glove.

As I have often said, a tracking fail is a great learning experience for dog and handler. Sky did a lot of good things that day, but there is still work to do. This test was certainly a great reminder to train on as many surfaces as you can find, because you never know what you will encounter on test day. It was a great test, great judges, great volunteers, including our own Janet Kelly who so graciously agreed to serve as a track layer, and great entrants.
